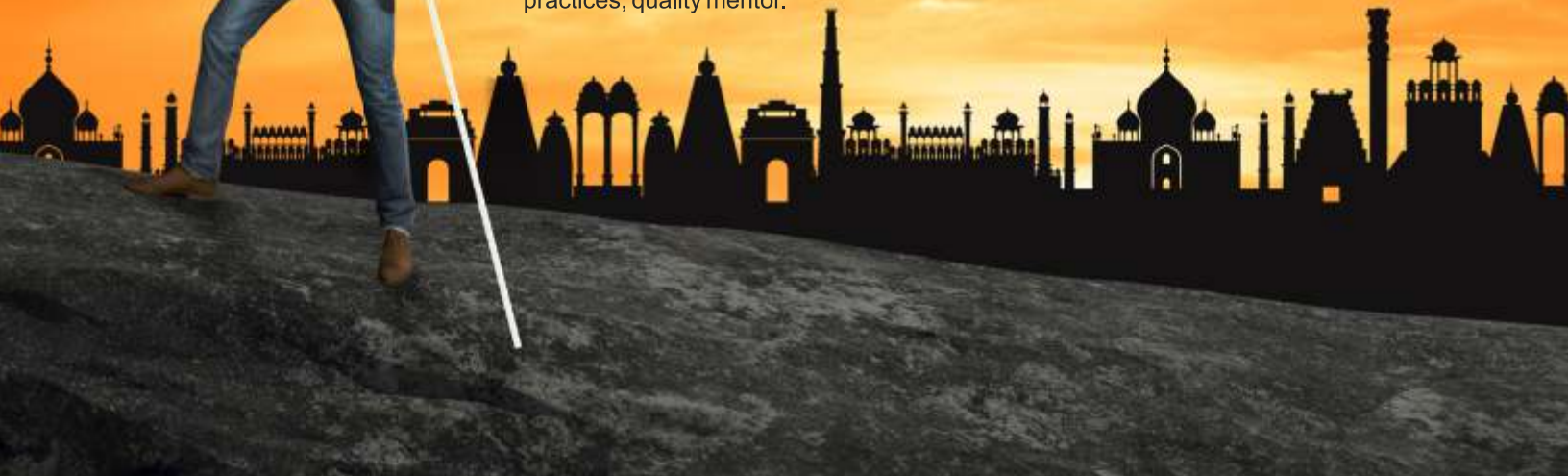

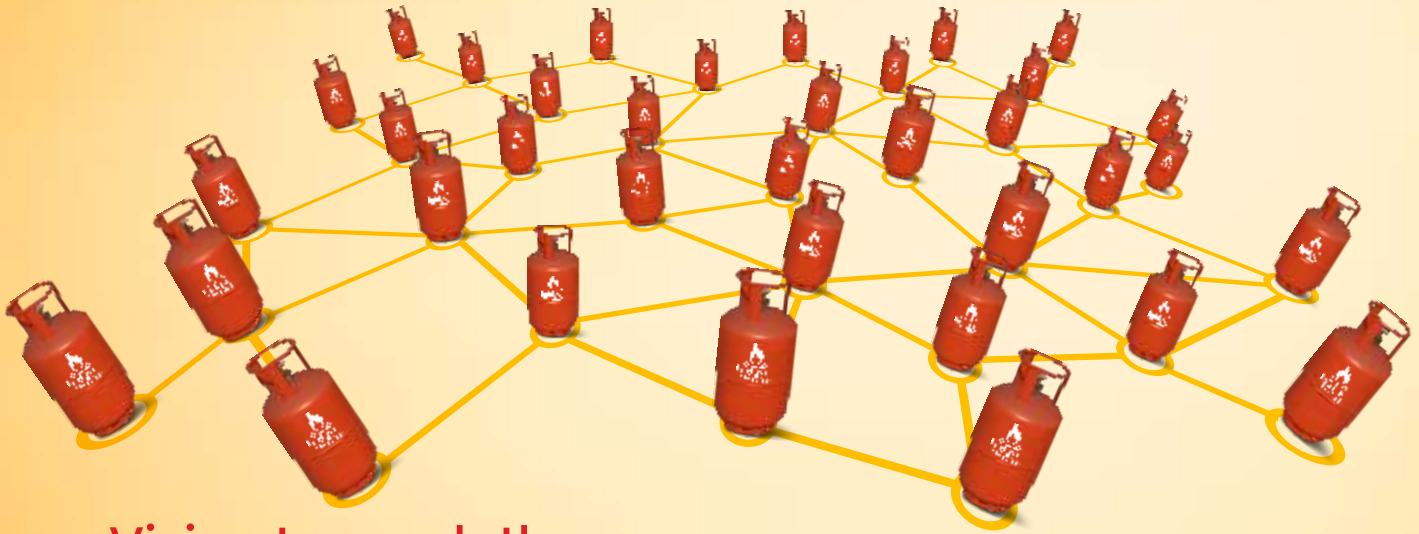

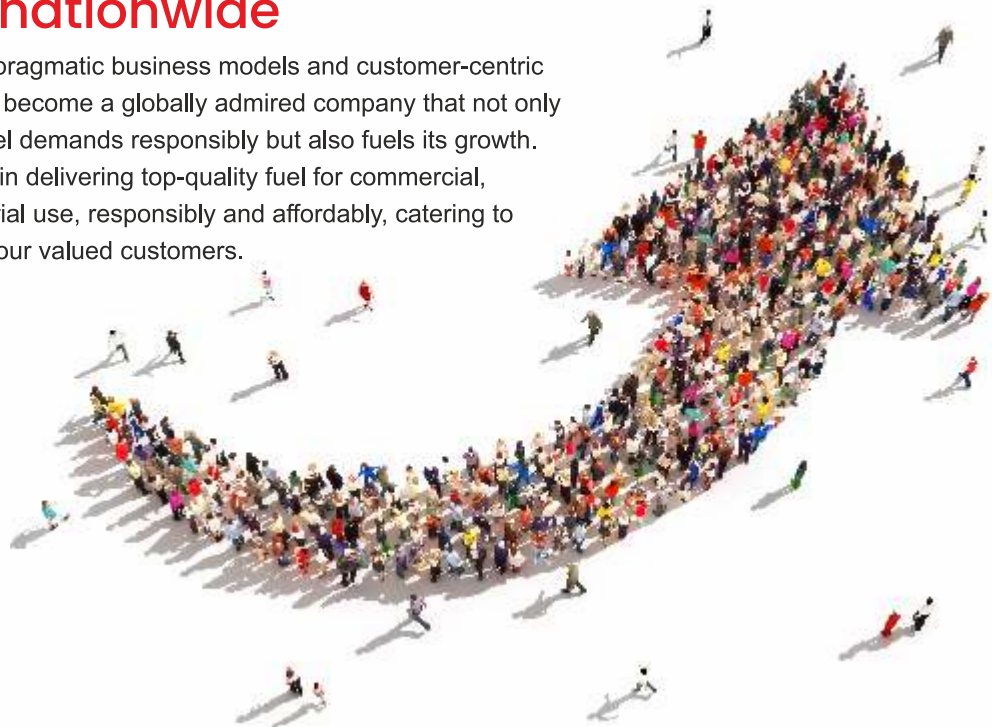

Our Cylinders

We use high quality aluminium, steel and mixed alloy for making and developing gas cylinders. Various factors on which the selection of the kind of metal used in manufacturing these cylinders depends are:

LPG is stored in especially designed storage tanks having high tensile strength and durability. Our packaging is available in convenient sizes ranging from 4 kg to 17 kg for application in various entities.

Our Business Model

Gas will be supplied to consumers through authorized area-wise Distributors/Dealers. The Distributor/C&F will facilitate the supply to the dealer by providing the godown, logistics, etc. The Distributor/Dealer will be authorized to supply LPG from Indira Gas and Petroleum to Retailers.

The Dealer will be in direct coordination with the company and will take bookings for gas connections directly from consumers, such as Domestic Users or Commercial Users, within their defined region. The dealer must ensure the transfer and exchange of Empty/Refilled cylinders from the Godown of the Centre Warehouse to their own facility. They will also be responsible for ensuring the availability of sufficient logistics at their end to deliver and pick up empty/filled cylinders from customers.

The Dealer must obtain necessary statutory licenses and implement safety measures with our support to purchase, store, and operate the LPG business in compliance with the requirements of concerned legal and governmental bodies.

Process for applying LPG dealership and license registration

STEP-1

Selection of LPG Distributors

The applicant fulfilling the following basic minimum eligibility criteria can apply for a registered distributorship license and start their own business at the earliest.

Minimum Eligibility Criteria

- The applicant should be a resident of India
- The applicant shall be minimum matriculated or recognised equivalent as per educational board recognised in India.
- The applicant should be between 21 years to 65 years of age.
- The applicant should have minimum land of 800 sqft of area for building godown for the storage of filled LPG cylinders.
- The applicant should be financially sound.
- The applicant should not have any criminal record.
- The applicant should have basic identity documents.

If you are eligible for all the above conditions, then you can apply for Indira Gas Agency with following requirements:

Distributorship Process

Guidelines: How to become a Dealer of Indira Gas and Petroleum Private Limited

We fulfill the need of commercial and bulk customers through our B2B offerings. Indira Gas and Petroleum gives prominent advertisement in daily newspaper and promotional pamphlets for selection of LPG Gas Distributors through our distributorship at various location in various states. The company has framed selections guidelines for the proposed distributors.



- Application forms for Indira Gas dealership may be submitted by eligible candidates in standard format through online as well as offline mode.
- The application form for distributorship is available on our website www.indiragas.com as well as physical office. Go to our website and click on “Apply Now”. Now download the application form, fill in your basic details and upload the form with the application fees through online mode of payment.
- The application fee can also be paid online through demand draft or cheque drawn in favour of “Indira Gas and Petroleum Private Limited” to be attached with the application form and sent to our office address through courier or in physical.
- After receipt of application form the applicant a personal discussion will be arranged in our office with prior information to know about each other and the business model, profitability etc of the business.
- If the applicant is selected then a Letter of Intent (LOI) will be issued with important conditions of business. If the applicant agrees and acknowledges the letter of Intent(LOI), the business agreement will be signed with the applicant. Before signing the agreement the applicant will pay the agreement charges either as dealer or distributor/C&F.
- On acceptance of application by the company, the applicant shall apply for registered license with the Indira Gas and Petroleum Private Limited for LPG Distributorship by paying the license fees. The amount paid towards license fees shall be non refundable.
- The application shall be processed within maximum 48 hours to complete documentation and confirmations.
- If the applications is found in order with no defects, then within next seven days of application for licensing of LPG distributorship, the applicant shall be given documents authorising the supply and distribution of Indira Gas LPG cylinder within the area/Block/District/Gram Panchayat listed/selected by you in the application.
- Refundable security deposit has to be deposited within maximum next 3 days of application process confirmation.
- After obtaining the authorised license for supply of LPG, the applicant shall apply for the stock of new LPG connections as per the rules and guidelines of the company.

Special Guidelines for the Stock and Supply

After completing the formalities for application and licensing, the applicant shall apply for stock from the company as per the mandatory guidelines given below.

For Dealer/Sub Dealer

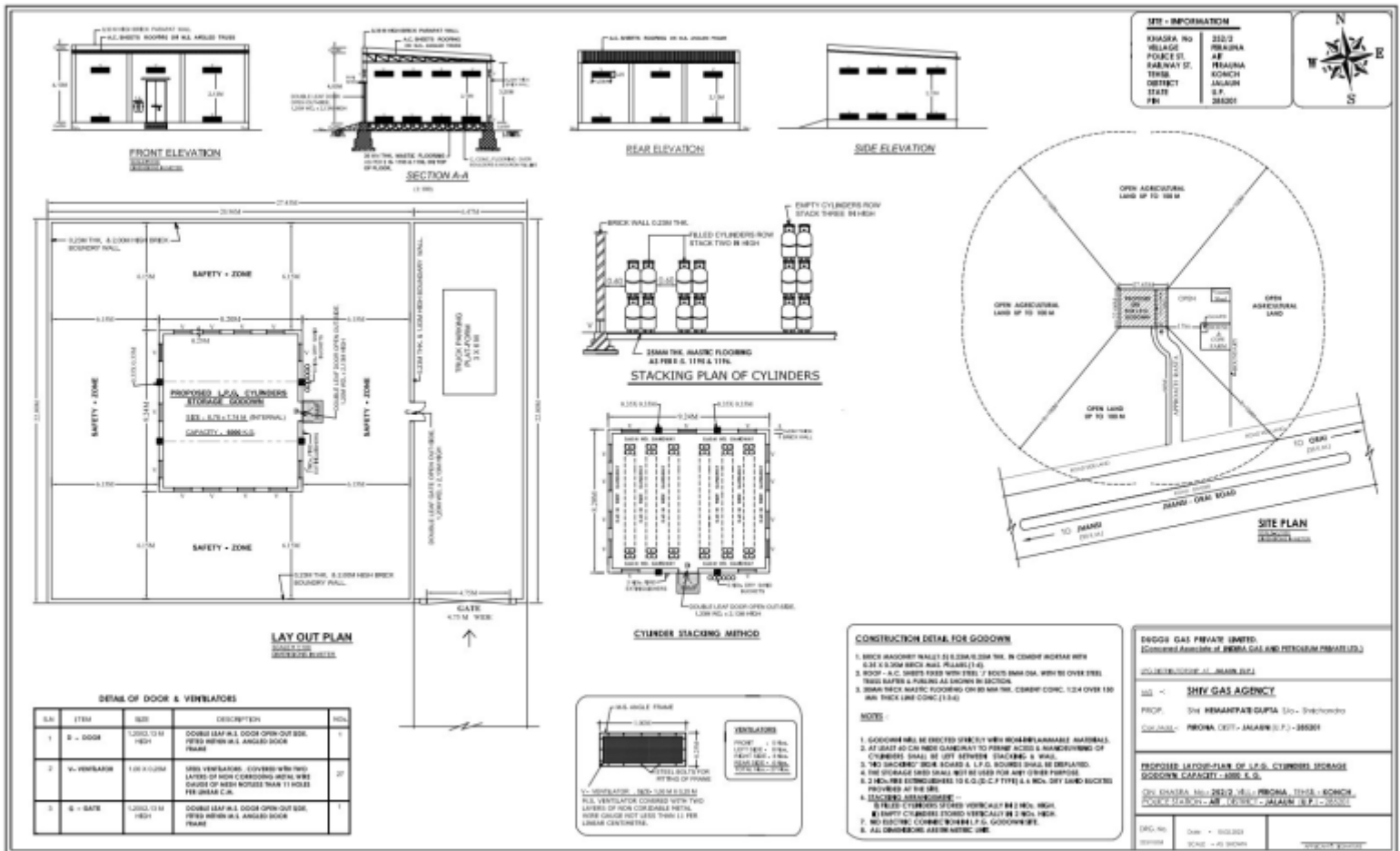
After the allocation and appointment of dealer/sub dealer on the allocated Block/gram panchayat the dealer/sub dealer has to purchase the LPG stock up on advance payment of money.

The dealer/sub dealer has to make sure that he has obtained the required GST registration in the name of this firm.

Note: The dealer/ Sub Dealer has to mandatorily submit a copy of GST registration form with the company for billing purpose. Apart from this, the dealer/sub dealer shall manufacture the godown for storage of filled LPG cylinders as per the statutory guidelines and standards of PESO.

The godown shall be designed and manufactured as per standard of PESO in the format laid down below.

Tenure of Distributorship

The tenure of Indira Gas LPG distributorship shall be for an initial period of five years and renewable for every five years, thereafter to examination and fulfilment of eligibility criteria and performance of distributor:

Other Important Context

The dealer/ sub dealer must be aware of all the rules and regulations followed by the supplier company. The dealer/ sub dealer shall submit important documents like memorandum of undertaking, self-declaration etc from time to time as required.

In the event of disagreement/ argument, the company shall be responsible for appointing a mediator who shall take a justified decision upon equitable basis.

The Company maintains a special supply department and the head of such department shall be responsible for all the matters related or incidental thereto.
